

## Assemblymember Cecilia Aguiar-Curry (D - Davis)

As the first woman mayor of Winters, Cecilia Aguiar-Curry **worked to secure computers for every 6th-grader in the city**, bridge the digital divide by bringing broadband to rural communities, build a state of the art senior housing development, and establish an Ag innovation hub in Yolo County. She also helped bring a \$75 million PG&E training facility to Winters and worked to establish the Berryessa Snow Mountain National Monument, to protect environmental lands across five counties. She is Chair of the Yolo Housing Commission, Vice-Chair of the Yolo County Water Association, and serves on the Board of Directors of the Sacramento Council of Governments. Aguiar-Curry earned degrees in business administration and accounting from San Jose State University, after which she launched a consulting firm specializing in water, public policy, and community outreach. Previously, she was chosen as one of Congressman John Garamendi's "Women of the Year" in 2015.

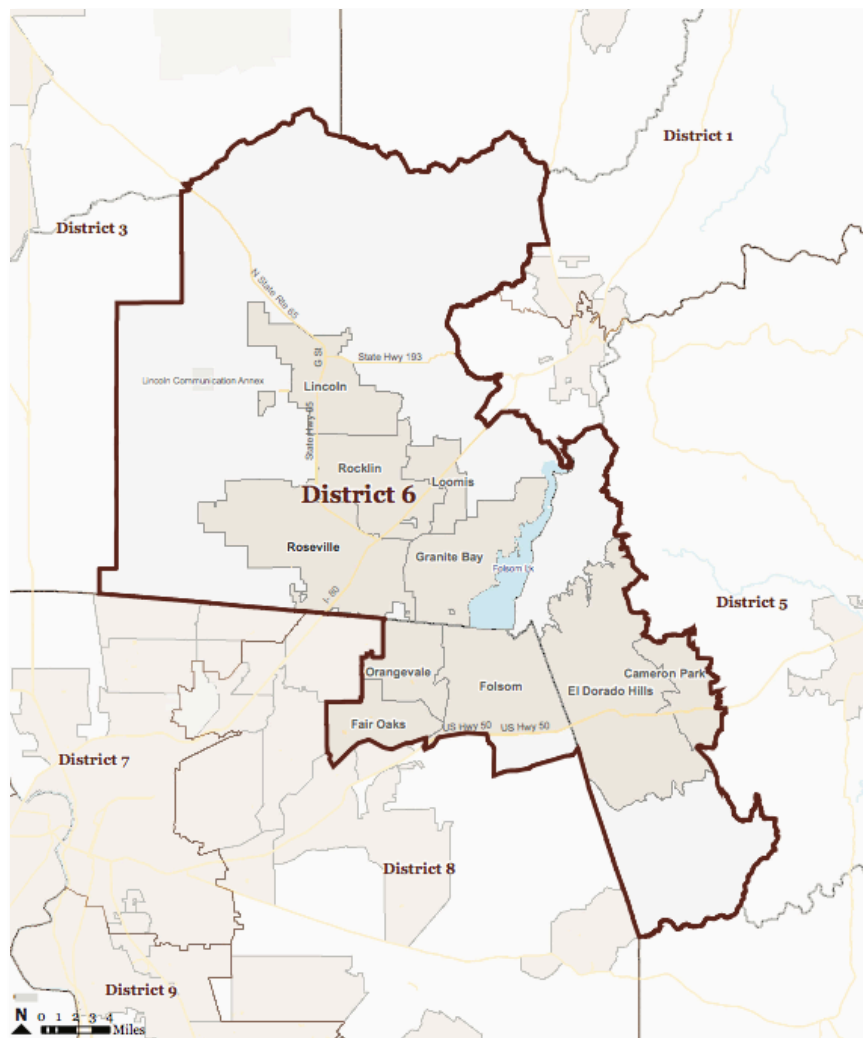

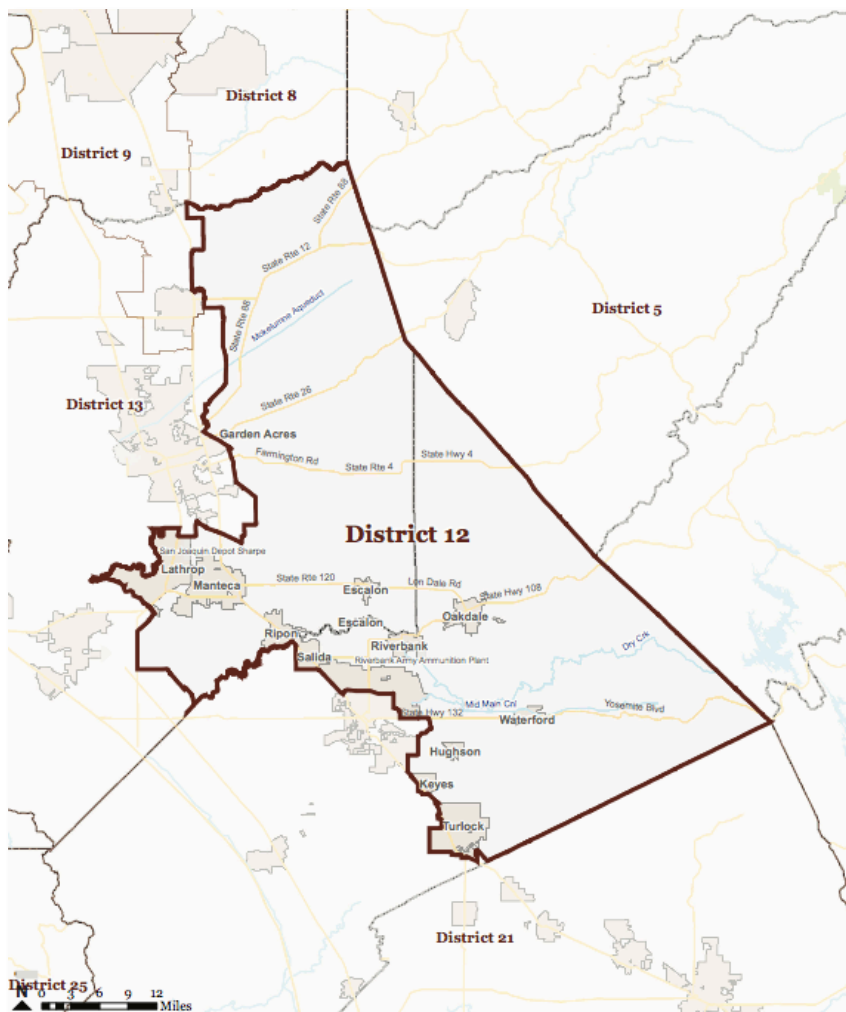

## Assemblymember Tim Grayson (D - Concord)

14th District

Tim Grayson previously served as the Mayor of Concord and, before that, as the Concord police chaplain. Most recently, Grayson served as a member of the Concord City Council. As police chaplain, Grayson initiated Concord's first Daytime Curfew Ordinance to lower the incidence of older students skipping school by allowing local police officers to **return truant students to school**. He also initiated the region's first "Community Court" for first-time **juvenile offenders**, providing support and help to intervene and lead young people on the path to responsibility and productivity instead of immediately to Juvenile Hall, and **reinstated police school resource officers back onto local K-12 public school campuses** by working closely with school districts to identify necessary funding. Grayson also identified and approved 110 acres of land for future use as a four-year public college or university, the first of its kind in Contra Costa County.

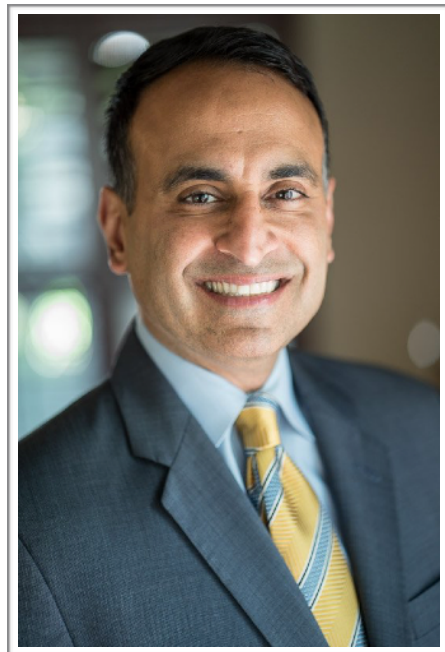

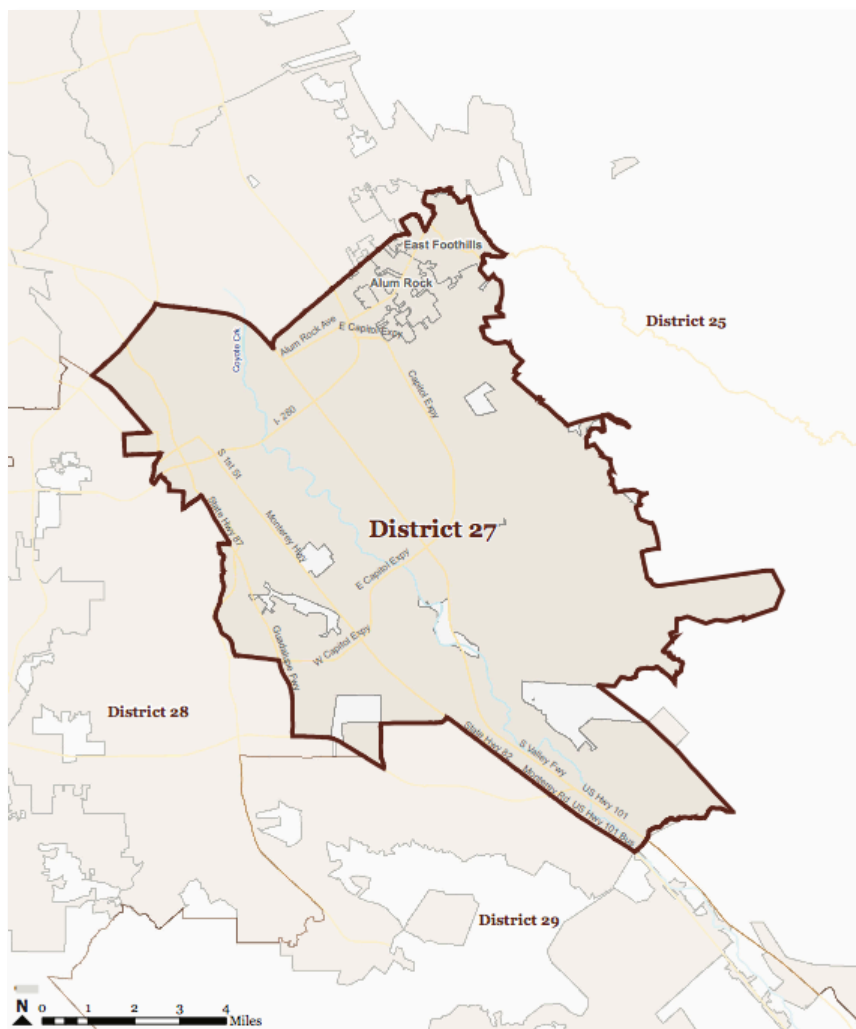

Anna Caballero was first elected to the California State Assembly in 2006, where she served for four years. While in the Assembly, she voted to extend state student aid to undocumented students applying for citizenship and created a parks grant incentive for park poor communities who build affordable housing. Prior to her election to the Assembly, Caballero served as a member of the Salinas City Council for seven years and then as the first female Mayor of Salinas. As mayor, she raised over \$80,000 in private funds to fund the city libraries and put a ballot measure on the ballot to raise money for essential services during a state budget crisis. After graduating from law school, Caballero moved to Salinas to provide legal services to farmworkers and started Partners in Peace, a non-profit to develop strategies to reduce youth and gang violence. Most recently, Caballero served in Governor Brown's cabinet as Secretary of the Businesses, Consumer Services and Housing Agency from 2011-15.

Elected to the San Diego City Council in 2008, Todd Gloria led the way for San Diego's first permanent year-round homeless service center. He served as City Council President in 2013 and 2014 and as Interim Mayor for the City of San Diego from August 2013 until March 2014. As a board member for the Metropolitan Transit System and the San Diego Association of Governments, Gloria helped expand trolley service, implement Bus Rapid Transit service through the region, and add bicycle and pedestrian infrastructure. Since 2011, Gloria has served as the chair of the San Diego City Council's Budget and Government Efficiency Committee, where he helped restore critical services and championed increased infrastructure investment. Prior to serving on the City Council, Gloria served as District Director to U.S. Congresswoman Susan Davis and worked for the County of San Diego's Health and Human Services Agency. He holds a Bachelor's degree from the University of San Diego.
